SIXTEENTH REPORT AND FEE NOTICE OF COSTS AND EXPENSES OF THE SUCCESSOR TRUSTEE AND NAMED PLAN FIDUCIARY OF THE CASTLETON GROUP INC. 401(K) PLAN

Pursuant to the Order of the Court dated October 2, 2008, the Successor 401(K) Plan Trustee and Named Plan Fiduciary of the Castleton Group Inc. 401(K) Plan (the "Plan") submits this Sixteenth Report and Fee Notice for fees and expenses for the period of January 1, 2010 to January 31, 2010.

ACTIVITY REPORT

During the months of January 2010 and February 2010, Receivership Management, Inc. (RMI), continued its work finalizing certain aspects of the 2007 Audit and Form 5500, continued its work on preparing a Voluntary Compliance Program Application (VCP) and continued its efforts in the collection of missing funds.

Work on the VCP filing began in late November, 2009. This work has required significant research in gathering plan documents, loan documentation, and compliance amendments adopted during the Plan's operations. Besides the seven failures that were noted in the Fifteenth Report; seven more plan failures have been identified as a result of preparation for the VCP filing, for a total of fourteen (14) qualification failures. Also during the months of January and February 2010 significant efforts to collect the VCP filing fee of \$15,000 were undertaken. Under IRS guidelines, the VCP filing fee cannot be paid for by plan assets and must be paid by plan sponsors.

Based upon research and review of operations by Castleton, and information provided by Transamerica, the fourteen qualification failures are:

1. ADP/ACP Testing Failures

- 2. Ineligible Employees Allowed to Participate
- 3. Excess contribution in violation of IRC Section 415
- 4. Top Heavy Testing Failures
- 5. Defaulted Plan Loans in 2008
- 6. Ineligible Employer Allowed to Participate
- 7. Client Adoption Agreements Not Properly Retained
- 8. Client Adoption Amendments Not Properly Obtained
- 9. Improper Employer Participation Termination
- 10. Failure to Provide a Timely Required Minimum Distribution
- 11. Plan Participants not allowed to elect form and amount of Required Minimum Distribution in 2008
- 12. Current Plan Document not congruent with present Freeze Order of the Court
- 13, Freeze Order prevents plan operations as outlined in Plan Document
- 14. Defaulted Plan Loan in 2006

Throughout January and February 2010, the Successor 401(K) Plan trustee and her staff have worked to correct Client Adoption Agreement and Amendment problems with 19 affected employers. Additionally, as earlier indicated, documentation of participant loans and other information from Transamerica generated additional questions and concerns as to how loans were handled at the end of 2007 and the beginning of 2008. These issues make up a part of the VCP filing.¹

Significant activity involving the collection of missing funds occurred during the months of January 2010 and February 2010. Various motions necessary to objecting to the treatment of the 401(K) Plan's claim in the Suzanne Clifton Chapter 11 bankruptcy proceeding were prepared and filed. The Plan has asserted claims against Ms Clifton for her actions and/or inactions as the former Plan trustee and president of The Castleton Group Inc. Hearings regarding these motions and objections were scheduled for February 24, 2010, but were postponed in an effort to resolve matters pending in the Clifton Chapter 11 Bankruptcy. Negotiations during the months of January and February 2010 resulted in a negotiated settlement that preserved the Plan's claim in the Clifton Bankruptcy and clarified the Plan's position in relation to agreements between the Chapter 7 Trustee of Castleton Group Inc. and Ms. Clifton. These negotiations involved both Ms. Bryant's litigation counsel and North Carolina bankruptcy counsel.

In January, 2010, the U.S. Department of Labor filed suit in the District Court of North Carolina against Ms. Suzanne Clifton, Mr. Jay McLamb, Castleton Group Inc., the 401(K) Plan, and the Castleton Group Health Plan. The lawsuit is an ERISA enforcement action and names specific activities of Ms. Clifton and Mr. McLamb regarding violations of ERISA during the period prior to Ms. Bryant's appointment. Ms. Bryant has received a copy of the lawsuit and is proceeding to respond to the Complaint.

¹ The VCP fee of \$15,000 was collected. The VCP filing was submitted to the IRS on March 10, 2010.

ACCOUNTINGS REGARDING THE 401(K) PLAN

As noted in the Order of October 2, 2008, before causing the Plan to pay compensation, fees or expenses, the Successor Trustee is to provide written notice (the "Fee Notice") of such compensation, fees or expenses, by filing the Fee Notice with the Court, and by serving a copy to the U.S. Department of Labor, Employee Benefits Security Administration, Atlanta Regional Office, Atlanta, Georgia, and to all of the Participating Employers in the Plan. The Successor Trustee submits her Fee Notice and Activity Report on a monthly basis. If, within fifteen (15) days after filing of a Fee Notice, no objection to the Fee Notice or payment by the Plan of the compensation, fees or expenses described therein is filed with the Court, such compensation, fees or expenses shall be deemed reasonable expenses of the Plan and shall be paid by the Plan without further action or approval of the Court.

In an effort to reduce costs, copies of this Sixteenth Fee Notice and Report are being posted to RMI's website and post cards are being mailed to notify the 47 participating employers of the filing and its being available on the RMI website.

Attached hereto as **Exhibit 1** is a schedule of the hourly rates for the Successor Trustee and the hourly rates of any staff of Receivership Management, Inc. that might be used to carry out the terms of the Court's Order of October 2, 2008.

Attached hereto as **Collective Exhibit 2** are expense summaries for the period of January 1, 2010 through January 31, 2010. Total expenses, as listed on Exhibit 2 include \$3,960.00 in Successor Trustee fees, \$17,111.90 in legal expenses and \$7,931.56 in contract labor expenses (which include auditor fees and identified charges for other fees, postage, copies, telephone, travel, etc.).

In anticipation of this filing, a draft of this Fee Notice and the invoices were shared with Mr. Chris Graebe, Counsel for certain Plan Participating Employers.

In the absence of any objection, reimbursement of \$3,960.00 in Successor Trustee fees, \$17,111.90 in legal expenses and \$7,931.56 in contract labor expenses will be paid from the Plan in accordance with the Court's October 2, 2008 Order. 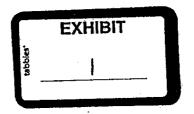

Overhead charges are allocated pro-rata based upon the number of hours billed to a receivership. Overhead charges are included in the hourly rates shown above. Overhead includes expenses of a general nature which cannot be charged to a specific receivership. Examples include depreciation on equipment, insurance, etc.

Rent is allocated to a project based on a physical presence (i.e. Files, records, and other documentation) at the RMI location and the time spent on that project. It is by its nature an estimate and is normally set at the beginning of each quarter and remains constant during that quarter. It is charged, based on the preceding description, in addition to the hourly rates shown above. The allocation is reviewed each month and if there is a material change in either the physical presence occupied or time spent on the project, the rent allocation is adjusted to reflect current conditions.

Office Expenses which can be specifically identified to a project (eg. telephone, postage, copies etc.) are charged to the project as incurred.

Travel: Per Diem-\$39.00 for meals and incidentals (first and last day of travel 75% of per diem amount allowed). Per Diem paid only if overnight travel is required. Transportation: By private car: 58.5 cents per mile; By common carrier: Actual ticket cost at coach. Lodging: Actual amount charged.

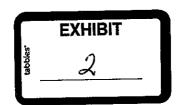
