**NOTICE OF PAYMENTS TO STATE UNCLAIMED PROPERTY FUNDS  
CONCERNING UNCLAIMED DISTRIBUTIONS FROM THE SERVICE AND  
BUSINESS WORKERS OF AMERICA LOCAL 125 BENEFIT FUND ESTATE**

Pursuant to previous Order of this Court (D.E. #1440, E.O.D. 9/29/08), the Independent Fiduciary files this notice of payments concerning the unclaimed checks from the previous distributions to claimants in this estate.

There were two distributions made from this estate resulting in a number of unclaimed checks from claimants who had filed claims, but who have since moved leaving no forwarding address. After receiving returned checks, the Independent Fiduciary first used the search services of Intelius to check for any updated addresses or location information for those claimants.<sup>1</sup> In addition, all phone numbers were called that were listed on the Proof of Claim form filed with the Independent Fiduciary. After the last distribution, a second search letter was sent out to all remaining claimants that were



not found by the previous efforts. Moreover, health care provider claimants with returned checks over \$500 were called to try to find new addresses. At the end of that process, there were 229 claimants remaining with unclaimed checks totaling \$109,961.10. The list of the unclaimed checks and claimants categorized by state is attached to this Notice as Exhibit 1.

The Independent Fiduciary believes all reasonable efforts have been used to find these claimants and, absent any objection from the Court, will proceed to make payments to the various State Unclaimed Property Funds as noted in the Exhibit. The Independent Fiduciary advises the Court that the payments will be made thirty (30) days from the date of the filing of this Notice.

Within thirty (30) days of the payments made to the various State Unclaimed Property Funds, the Independent Fiduciary will be presenting to the Court her Summary Final Accounting, Final Report and Request for Discharge.


